About This New Grant Opportunity - Please Read Carefully!

This special grant opportunity was funded through the Centers for Disease Control. The University of Michigan is leading this project, a 5 year, 3-city study of vacant land reuse and youth violence prevention. Youth involvement (ages 10 - 24) must be at the core of proposed projects for this opportunity, and a training on engaging youth will be provided to project grantees. As this is a study, project grantees will be contacted by researchers periodically, and will need to keep basic records of work performed on the vacant lots that are being improved. Forms for documenting work and maintenance will be provided to project grantees. Funds awarded can be used to pay stipends to youth involved in the project as well as for project installation and maintenance costs for 2016 (adult salaries or stipends will not be approved). Funds can also be used for project installation, materials, and small equipment. Professional maintenance cannot be paid for through, though contractors can be hired to do some initial cleanup or installation tasks that cannot be completed by volunteers). Funds will average \$1,700 per vacant lot the project is planning to green and maintain for the season. Funds will be granted to organizations through fiscal agents (unless the organization has 501(c)3 status). Organizations will not receive funding for maintenance beyond 2016 for improved lots, so maintenance plans should be completed for future years of the project. Projects will be owned and operated by the project grantees, and YNDC cannot provide project maintenance or grasscutting. This funding will be awarded to improve currently vacant and unused lots - they cannot be used for improvements to existing projects, although project expansion to new currently vacant lots is acceptable.

Eligible Applicants

Eligible applicants are located in the city of Youngstown and include groups of residents, neighborhood associations, businesses, non-profit organizations, and local faith-based organizations. All applicants should be committed to working with youth to install and maintain awarded projects.

Eligible Project Sites

All proposed project sites must:

- Be located within the Youngstown city limits.
- Be located in a visible area that will impact the stabilization of the neighborhood.
- Have community support from residents or businesses in close proximity to the project.
- Involve youth in all aspects of the project, including maintenance.

Criteria for Selection

Once applications are submitted, they will be reviewed by YNDC staff and the project review committee. Applications will be judged by the following criteria:

- Does the project involve and benefit youth?
- Is the project or proposed phase of the project feasible during the grant timeline?
- Is the project location impactful to your neighborhood?
- Does the project have a clear long-term maintenance plan?
- Does the project have community support from the neighborhood?

About Youngstown Neighborhood Development Corporation

Youngstown Neighborhood Development Corporation (YNDC) is a citywide multifaceted neighborhood development organization launched to catalyze strategic reinvestment in neighborhoods throughout the City of Youngstown. The mission of the organization is to improve the quality of life in Youngstown by building and encouraging investment in neighborhoods of choice for all. YNDC operates a broad portfolio of programs to achieve this mission, including home rehab, home repair, home boarding, grasscutting, community workdays, urban planning, vacant land reuse, and small business development.
