In order to avoid the late registration fee, please register your Property or Properties within 30 days of receipt of this letter. If you do not register your property or properties you are subject to a fine of up to \$100.00 per week per structure until your rental license is renewed. All of your properties included with this notice MUST be registered in order to be considered in compliance with the Rental Property Registration ordinance (546.11).

If you need more registration forms you can copy the one enclosed, download the registration and inspection forms at www.youngstownohio.gov or you may call our office and we will mail you forms.

The fees for the RPR Program remain the same:

SINGLE FAMILY: \$40.00.

MULTI-FAMILY: \$40.00 for the first unit and \$25.00 for each additional unit in that structure.

Rentals that are Section 8 properties are NOT subject to registration. Properties that are under a Land Contract ARE required to be registered unless you can prove that a valid contract is recorded with the Mahoning County Recorders Office. You can fax this information to the RPR office at 330-743-3602.

When filling out your registration forms, make sure that you include the phone number and the current mailing information of the owner. Failure to include this information invalidates the registry form and the owner will be subject to a \$100.00 weekly fine for non-compliance of the Rental Property Registration ordinance until the proper information is provided.

Please disregard if you feel you have received this letter in error or have already registered your rental property.


