



## **Glenwood Corridor Improvements**



YNDC's Community Engagement and Organizing team has recruited 45 business owners and community leaders to formalize Glenwood Neighbors into a corridor business association to share information, coordinate community activities that promote a vibrant businesses corridor, and to take action around common interests and issues affecting businesses along Glenwood Avenue. Glenwood Neighbors will hold its first official meeting in April.

YNDC is developing a plan to clean up and green 6 overgrown and asphalt-riddled vacant lots on Glenwood Avenue where buildings once stood. This is part of a decade-long effort by YNDC, the City of Youngstown, and the Mahoning County Land Bank to clean up, assemble, and maintain vacant lots on the corridor to restore a basic sense of order for the benefit of the surrounding neighbors and businesses. Over time, some of these sites will be transformed into community open space while others may have long-term potential for redevelopment.

# **Neighborhood Cleanup**

YNDC's Grass Cutting and Cleanup
Team boarded 22 houses this quarter in neighborhoods throughout Youngstown.
The team cleaned up 124 vacant structures and lots in the Newport Neighborhood on Youngstown's south side as part of a coordinated effort to clean up and improve neighborhood conditions and improve community safety in areas of the city notorious for illegal dumping. A total of 909 cubic yards of brush and illegal dumping debris (equivalent to 30, 30-yard dumpsters) and 509 illegally dumped tires have been removed from the neighborhood.

Wolford's Rolloff, Inc., a longtime partner in YNDC's work, donated staff time and dumpsters to assist with clearing hundreds of cubic yards of overgrowth from vacant lots and to uncover over 1,000 linear feet of overgrown sidewalks. Additional cleanup work to hundreds of properties in multiple neighborhoods on the South Side and East Side are planned for the coming months in partnership with the City of Youngstown, Councilwoman Anita Davis, and Councilman Jimmy Hughes.










# **Youngstown TreeCorps**

YNDC has begun preparations for spring tree planting as part of Youngstown TreeCorps, an initiative led by YNDC and supported by the Healthy Community Partnership to plant 250 shade trees throughout the city with multiple neighborhood groups and community organizations.

YNDC's team has begun visiting planting sites and coordinating with multiple partners to prepare a tree planting plan for the spring. Plantings will take place this spring and fall.









# Neighborhood Engagement and Organizing

YNDC's team organized a campaign to hold ONE Health Ohio accountable for keeping their promise to begin construction on their planned Glenwood Avenue health clinic in the former Bottom Dollar grocery store on Glenwood Avenue. ONE Health Ohio purchased the property from the City of Youngstown in 2018 with the intention of opening the clinic in 2 years; the project was initially announced in 2016. Since that time, very little progress has been made and the building has continued to deteriorate despite continued promises to begin construction soon. ONE Health announced publicly that construction would begin in December 2022, but by March 2023, no activity had begun.

YNDC's engagement and organizing team collected 53 signatures from Glenwood Avenue business owners and neighborhood leaders and submitted a joint letter asking the CEO of ONE Health Ohio to provide a clear public timeline for breaking ground on construction or to return the building to the City of Youngstown so that another productive use can be identified. The letter garnered significant media attention, and further community action will be taken in the coming months if no clear signs of progress materialize.







# Neighborhood Engagement and Organizing

YNDC's Community Engagement Fellow, Kayshia Washington, has been holding oneto-one meetings to get to know neighborhood leaders and community stakeholders throughout the Youngstown in order to get to know more about them and to identify ways to strengthen their engagement in our work. Kayshia has completed 32 one to ones to date and has dozens more scheduled in the coming weeks. Kayshia will also be participating in neighborhood meetings throughout Youngstown in the coming months to learn more about issues affecting our neighborhoods, update groups on YNDC's programs and services, and identify additional leaders interested in getting involved in our work.
